## New Direction for the State Floodplain Management Program

#### **New State Floodplain Coordinator**

As most of you know, Veronica Chavez was hired as the new State Floodplain Coordinator. She began working at the New Mexico Department of Homeland Security and Emergency Management (DHSEM) in the role of State Floodplain Coordinator on September 25<sup>th</sup>. Veronica worked for DHSEM as a Recovery Officer, providing technical assistance to local communities for both State and Federal disaster recovery assistance. That technical assistance included overview of the National Flood Insurance Program.

Prior to working for DHSEM, Veronica worked for the Office of the State Engineer on water rights compliance and risk analysis. She has a Bachelor's degree and a Master's degree in Geography and Environmental Science. Veronica is a tremendous asset to the State Floodplain Management Program. We know that you will enjoy working with her as we move forward with advancing the State Floodplain Management Program.

#### NMFMA/DHSEM Survey

At the Angel Fire NMFMA Workshop, DHSEM handed out a survey for all communities. The intent of the survey is to gather information about the 104 NFIP communities in New Mexico and to get input from all communities on improvements that could be made in the State Floodplain Management Program. The survey is two-pages long and is due back to DHSEM by October 15<sup>th</sup>. In general, the survey asks for;

- 1) up-dated community contact information,
- 2) copies of floodplain management ordinances and NFIP administration agreements
- 3) technical assistance requests and
- 4) suggestions for program improvements

The CFM exam is proctored at each NMFMA conference/workshop. If you are interested in taking the exam, please remember that no matter what paperwork or on-line registration you submit for any specific workshop, class, or other function, **YOU MUST SUBMIT A CFM EXAM APPLICATION PACKET** to the Certification Board before you can be scheduled to take the exam. The packet is downloadable from the Certification page of the NMFMA website. The Application Packet should be mailed to the Roswell address noted in the packet, or emailed to me at nmcfm@cableone.net . Let me now if you have any questions.

Don't forget that the continuing education credit requirements for maintaining your CFM have changed. You are still required to earn at least 16 CECs during each 2 year period, but you no longer are required to earn CECs every year. The CFM Program is explained in the Charter, which can be found on the NMFMA web site on the Certification page and also in the Resource Library.

We have a process to submit your CFM renewal online if you would rather not send an envelope and stamp. Go to the Event Calendar and look for the last day of the month that your CFM renewal is due (only the next immediate renewal date will have this link). There you will find a link to CFM Renewal, which is a registration page similar to a conference or workshop registration page. Just click on CFM Renewal and follow the instructions as though you were registering for a workshop. Click on complete registration. Enter your card info and submit. Don't forget to email me a copy of your renewal application to complete the process. If you renew before the deadline of January 1 or July 1, the fee for renewal is \$25. If you wait until after the first, the fee is \$25 plus a \$25 late fee, or \$50. Renew your CFM as soon as you get my reminder letter, which is sent out prior to each of our workshops, if you have enough CECs to renew. Waiting until after the end of the month the renewal is due will result in decertification.
