

# From the State Floodplain Coordinator

Training, training, training!

There will be many training opportunities coming up for the membership to take advantage of. After the Fall Workshop in Ruidoso anticipate invitations to free monthly webinars running about 45 minutes. These webinars will be hosted by Dave Hiegel from FEMA Region VI and cover a variety of topics such as;

- Higher Standards
- Which Grant for Which Type of Project?
- How to utilize Social Media to promote your floodplain management program
- Master Drainage Plans
- Perfect Permit
- Flood Proofing
- Mobile Homes

Additionally, there will be two L273: Managing the Floodplain through the NFIP course offerings. In the past, this course has been held in Albuquerque or other central location. This year, these courses will be held in the eastern and western areas of the State. If you are in either of these regions and would like to have the course held at one of your local facilities, please contact me for further coordination. Some advanced course offerings will be coming to NM as well; L278: NFIP/CRS and L194: Advanced Floodplain Management Concepts. Anticipate dates and locations for these courses soon.

A new course, AWR-362: Flooding Hazards: Science and Preparedness, has recently been certified by FEMA and will be offered by the National Disaster Training Center **NDTC** in NM in the month of August. This is a one day course that will be held on August 21, 2018 at the San Miguel County Commission Chambers. # **New Mexico Certified Floodplain Managers**

The CFM exam that is used in New Mexico is the same exam used everywhere in the US. Over the past several years the exam has undergone lots of changes in an effort to bring its status closer to other exams used by professional groups and agencies. The exam now has 2 maps instead of one and includes several questions about flood-plain management in coastal regions. The questions on the exam fall into several categories: Overall Context of Floodplain Management, NFIP Regulatory Standards, Regulatory Administrative Procedures, Flood Insurance, Floodplain Mapping, Natural and Beneficial Functions, and Flood Hazard Mitigation. A good study document for preparation to take the exam is the FEMA 480 Desk Reference and Study Guide for Local Officials. The CFM exam is proctored at each NMFMA conference/workshop and after the FEMA 273 classes. If you are interested in taking the exam, please remember that **YOU MUST SUBMIT A CFM EXAM APPLICATION PACKET** to the Certification Board before you can be scheduled to take the exam. The packet is downloadable from the Certification page of the NMFMA website. You can either mail your application and fee to the Roswell address noted in the packet, or pay for the exam when you register for the conference or class and email the application to me at <a href="mailto:nmcfm@cableone.net">nmcfm@cableone.net</a>. Let me know if you have any questions.

Every NMFMA member gets a reminder email from our web site to submit the annual NMFMA membership renewal fee of \$35 by January 1. Those CFMs whose biannual CFM renewal fee of \$25 is due on January 1 will also get a reminder letter from me by email. Don't get confused. Some of you will get 2 reminders and they are BOTH due. You can pay your membership dues by logging onto the web site and clicking on the payment due link by your name. You can also pay your CFM renewal online by going to the Event Calendar, January 31 or June 30 (whichever coincides with your renewal due date) and clicking on CFM Renewal. Follow the instructions as though you were registering for a workshop. Click on complete registration. Enter your card info and submit. Don't forget to email me a copy of your renewal application to complete the process. If you renew before the deadline of January 1 or July 1, the fee for renewal is \$25. If you wait until later, the fee is \$25 plus \$25 late fee, or \$50 total. You can always call me at 575-937-1691 if you have any questions

## **Base Level Engineering**

Base Level Engineering is now available for the following four areas of New Mexico.

- Rio Hondo Watershed
- Animas Watershed
- Curry County
- Roosevelt County

Community meetings were held in Aztec, Clovis and Portales this spring and the BLE data will be available on the new, faster BFE Viewer by the end of August.

For a quick review Base Level Engineering (BLE) data is produced on a countywide or watershed geography and is only produced where high quality ground elevation is available. The BLE data creation process incorporates automated modeling techniques with traditional model development and manual data entry procedures to produce regulatory quality flood hazard boundaries for the 1-percent annual chance event as well as estimates of flood hazard boundaries for multiple recurrence intervals.


